"Solving the Disunity of the Urantia Revelation and Reuniting Factions by a Method Adjudged by the Conciliating Commission Sojourning on Urantia, Using the Jurisdictional Plan of the Revelatory Commission whose Supervising Melchizedek Remains Charged with the Responsibility of The Urantia Book."

Greetings All Urantian Soldiers of the Circles,

These are my first personal thoughts upon reading the Unity Treatise, and perhaps my only report on it and on the status of the Unity attempts of the Urantia organizations and on their resistance to the Unity Treatise. Before reading on, if the Unity Treatise is not fresh in your mind, perhaps you should read it again (see attachment). Urantia is at the very brink of worldwide spiritual advancement, and needs your help now more than ever. You have today the chance to make a real difference in fostering the future development of Urantia, and achieve the goals for which *The Urantia Book* was given to us.

REPORT:

It has been a while since you were sent or told about the Unity Treatise. Since then all three Urantia organizations [Urantia Foundation (UF), The Urantia Book Fellowship (TUBF) and the Urantia Association International (UAI)] have rejected unity both by trying it on their own, and also by rejecting the "Simple Plan" for unity as recommended in the Unity Treatise. Unless you help now, there will remain competing Urantia organizations and multi-publishers of The Urantia Book causing schisms and future worldwide confusion. You can help today!

Recently TUBF, by unanimous vote, rejected any kind of unity with the UAUS/UAI and also voted to continue publishing their 'version' of *The Urantia Book*. UAI accepted TUBF's rejection of them with a whimper and said nothing about the TUBF's continued book publication. Urantia Foundation never said a word about unity, either by the TUBF and UAUS/UAI own means or by the "Simple Plan" of Unity in the Unity Treatise. Urantia Foundation never became involved—citing their Non-Interference Policy. UF also made no comment about TUBF's vote to continue publishing The Urantia Book as Uversa Press.

Urantia history is important to us today and to our future Urantia family! If not corrected, the actions of the organizations over last 62 years will have a dire effect on Urantia's future development. It should be noted here for your consideration that Urantia Foundation was the one that originally disenfranchised the Urantia Brotherhood (UB) in the first place, had stopped UB from using the name 'URANTIA' and the three

circle marks, and then immediately originated the unsanctioned International Urantia Association (IUA)—the forerunner of independent Urantia Association International (UAI). Even though the Urantia Brotherhood leadership was then behaving badly, one may ask: where was the patience toward brotherly resolution and Non-Interference Policy then? Was not the disenfranchisement of Urantia Brotherhood actually interference then that caused the Urantia Brotherhood's end, and should not UF rectify now while I t still has the chance?

And, where too is your voice for fostering unity now? Has it been added to those of us who have already petitioned UF, TUBF and UAI to Unity and one publisher? Where do you really stand?

This is a call to action! Are you a Soldier of the Circles in Michael's Army of Urantians who will **stand** on the side of Urantian progressive development, or are you one to remain a by**stand**er?

Either these organizations will embrace unity with one publisher or others will do so without them and do so without those who will <u>not</u> continue to stand up for the mandates of Michaels's Revelators!

As it stands now, the Trustees of Urantia Foundation are the only ones who can begin to set right "...the Disunity of the Urantia Revelation by Reuniting Factions..." But, they have not! To convince them to do so now requires your voice! So, this is a call to all Soldiers of the Circles to action!

I have waited these four months' time for you to digest the content of the Unity Treatise as I and many others have. The Unity Treatise has not gone away. Read it again to refresh your mind. You do not have to read it all, just the last five pages to refresh in your mind the Simple Solution to Urantia Disunity. Now that you have had time to assimilate it, when you re-read it, your Adjuster will help you to understand it more fully.

There are but four months left until Michael's 2,013 birthday celebration. The Unity Treatise is still here to help these organizations achieve Michael's Plan for Urantia through his authorization of *The Urantia Book*. This order to unity is in conformance with Michael's Plan. For it is said: "A Master Son may at will vary the order of the spiritual adjudication and evolutionary adjustment of the inhabited planets. And such Sons do make and carry out the plans of their own choosing in all matters of special planetary needs, in particular regarding the worlds of their creature sojourn..." Will you now join with Michael and with us to make yourself heard by the leaders of the three Urantia organizations that they should attempt unity as one publisher—Urantia Foundation, and one readership organization—Urantia Brotherhood, as it was planned by his Revelators? You have had sufficient time to discuss it with your Urantia associates and form your own opinion as to whether or not it has significant value enough for you to now act personally and also as a united group petition. That is support Michael on your own and also by adding your name to the *Unity Treatise*

Petition (see below for details) so that these three organizations, UF, TUBF and UAI, would implement the "Simple Solution" for unity given in the Unity Treatise. In short this would mean that you join us and ask UF, TUBF and UAI to attempt to do the following in order to fulfill Publication Mandates, and their own Principal and Concordant Objects, Purposes and Goals as is required of them since they were sanctioned by the Revelators. They can augment Unity and reestablish one publisher by adopting the Simple Solution in the Unity Treatise. What follows is a synopsis of the Conciliating Commission's Simple Judgment/Solution found in the Unity Treatise:

- 1. UF is to legally restore the name Urantia and the trademark circles, etc. to TUBF and assist them in the reestablishment of the Urantia Brotherhood (UB), and encourage UAI to join UB.
- 2. TUBF would assume its original name, Urantia Brotherhood (UB).
- 3. The Urantia Brotherhood would be given once again full legal use of the Trademarks by UF, and be recognized to be in good standing by UF, and TUBF would invite UAI to join them as the united Urantia Brotherhood under its <u>original and unchanged</u> Constitution and Bylaws.
- 4. In joining UB, UAI would eliminate the word, "personal" from its methodology of achieving the goals, purposes and work in the constitution of the new united Urantia Brotherhood.
- 5. The united Urantia Brotherhood (TUBF and UAI united together) would then be free to amend their Constitution as they jointly see fit, without interference by UF, but the new united Urantia Brotherhood is not free to amend "...the purposes, goals, and mandates of the Revelators..." established in the original UB Constitution.
- 6. Once UB is reestablished, UF will refrain from and end all of its involvement in the united UB. However, it still remains UF's responsibility to cooperate in all similar principal objectives with the UB. Cooperation is key! The new united Urantia Brotherhood, while granted the right to use the marks, will respect UF's legal right to the name "URANTIA" and the trademarks.
- (UF Concern: While the trademarked name "URANTIA" and the marks of the three concentric circles, etc., with all their inherent and legal rights, will exclusively remain under the ownership of UF, these should never be considered again to be removed from the UB <u>unless</u> UB tries once again to grievously attempt to take from UF the responsibilities of UF's Declaration of Trust (DOT) and all that implies. And even in that case, UF should use every possible avenue of conflict resolution, even to legal arbitration and/or by making final petition to the "...Conciliating Commission sojourning on Urantia..." These should be attempted first.)
- 7. There shall be but one publisher of *The Urantia Book* and that is UF.
- 8. Trustees/Leaders of the Urantia Foundation and the united Urantia Brotherhood should make it their first and foremost policy to center the Universal Father in their personal lives and bring this God-centered life into their organizations. Thus becoming spiritual leaders of God-centered spiritually motivated organizations.
- 9. To eliminate confusion within the minds of mankind, UF should establish unity within itself and "...lovingly forgive, restore, and re-enfranchise each one of their three disenfranchised Trustees."

- 10. UF and UB should once again share the 533 Diversey Parkway headquarters together to demonstrate their unity to the world with both of them using the same address as before. This will save financial and human resources. UB should once again become the fundraising arm of the UF.
- 11. With the re-establishment of new united UB, both UF and UB should make every effort to, "...actively find, foster, and invite..." all unaffiliated and disenfranchised readers and their groups to join forces with the Urantia Brotherhood in its worldwide mission in service to Urantia.

THIS IS MY FIRST PERSONAL MESSAGE TO YOU:

Except for those good souls who already contacted me, this is my first personal message to you regarding the Unity Treatise since it was first sent to the three Urantia organizations: Urantia Foundation (UF), The Urantia Book Fellowship (TUBF) and the Urantia Association International (UAI). It was only after they rejected it, that I sent the Unity Treatise to you, as I was asked to do by my anonymous friend. Since then, I have said to all of you that asked me, that "...I am not the author(s) of the Unity Treatise!" But, I have re-read the Unity Treatise a few times since sending it out to you and have since given it a lot of personal thought. I am convinced now more than ever that it is what it claims to be and I continue to pray that with your help UF, TUBF and UAI adopt it. This is now only possible with your help.

FUTURE OF UF, TUBF AND UAI IN DISUNITY:

Many of you who wrote and/or called me also asked me what would happen to the organizations if they should not unify as one brotherhood, not support one publisher, and not follow the Publication Mandates or their own Principal and Concordant Objects, Purposes and Goals, "...through (or by) the fostering of a religion, a philosophy, and a cosmology which are commensurate with Man's intellectual and cultural development." My answer to this question was that I sadly believe absolutely nothing will happen to them. I believe they each will simply be allowed to go on alone using their own devices, and having their own successes. They will be successful or not in doing their own thing with *The Urantia Book* and fulfill the needs of their supporters and membership, and will continue to do so as they see fit. The emphasis here is on the words "...their own..." But their work will be done without the full support of our unseen partners in heaven, on Urantia, and all of the Urantia readers on earth. TO UNITY TREATISE SUPPORTERS:

I wish to thank all of you who have read and accepted the Unity Treatise, and there are many like you with a spiritually motivated open mind, who upon receiving the Unity Treatise read it fully, understood its significance, evaluated its content based only upon its own merit and value, and have found it to be of vital importance to the future of our planet; and who also believe it should be seriously considered by the leaders of the Urantia movement of UF, TUBF and UAI. I addressed this entire letter to you personally. You are "Soldiers of the Circles" for Michael. We join united.

I also wish to salute all of you who had the spiritual insight to go the extra mile and acted already by contacting the three organizations UF, TUBF and UAI to tell them of your wish for true unity and one publisher by standing up for righteousness, with

steadfastness. I am with all of you who also recognize the love and caring for Urantia that is exhibited by the author(s) of the Unity Treatise for their presenting us with the Unity Treatise in order to help and assist us in resolving our disunity, and to help give us a clearer vision of Michael's long term plan for the advancement and future development of Urantia by his authorization of *The Urantia Book* in the first place. I, with you, also would like to thank the unknown author(s) of the Unity Treatise, whoever he, she or they may be, for their informative and helpful words and report on Michael's intended plan for *The Urantia Book* and what its organizational publisher and brotherhood of readers should be doing to help realize Michael's goals for the future of our world.

The Unity Treatise was delivered to us now when we are of most need, but who the postman was should be of no more concern to us as when you we receive a mailed greeting card from a love one.

TO UNITY TREATISE DISTRACTORS:

But if you are not one of these supporters of the Unity Treatise, you should consider that it was given to us for the long term advancement of Michael's Urantia Revelation. And, if you are with the minority of detractors who outright rejected the Unity Treatise based solely upon either: my introductory cover letter, its author(s)'introductory letters, its opening page, its warnings, its assumed source(s), its actual author(s), the unanimity of the author(s) or my friend who gave it to me, its authority, your disbelief that such a Unity Treatise was written for and directed to our Urantia Leaders, any of my typos in my preparing the Word/PDF format, any of my spelling or grammar errors or misprints that I may have made in it when I put it into a Word/PDF format from its original text, or even if you are one who rejected the Unity Treatise because of your distrust of me and my life personally, or for anything I may have said or written in the past, to you I humbly apologize for ever sending you the Unity Treatise, this letter and its attachments.

To you distractors, I ask that you please disregard this letter and attachments and erase them from your computer files. You need not read this letter any further! It is not meant for you! It was sent to you in error. And, if you wish, please let me know and I will endeavor to remove your name from my list of hundreds of Urantian Soldiers of the Circles who stand together for Urantia Unity, with one publisher of *The Urantia Book*, one Urantia Brotherhood of committed readers, and who also fully and unreservedly support Michael's Plan for the Fifth Epochal Revelation according to the instructions in the Publication Mandate and in the three organization's Principal Objects, Concordant Objects, Purposes and Goals as given to them in their <u>original</u> governing documents by the Revelators.

But still, I personally ask you: if you are a distractor but have not actually fully read the entire Unity Treatise with an open mind and spiritual eye, please for Michael's sake, Urantia's sake and for your own sake, please do read it now. I have attached it to this letter. And when you do read it, please try to envision it coming from our Master Son's perspective.

REQUEST FOR ACTION:

This letter is a formal request for you, the "Soldiers of the Circles," to now take action together to support Michael's farseeing plan for Urantia development that is described in the Unity Treatise. You are asked now to act together in unity by contacting UF, TUBF and UAI organizations officially as well as their leaders personally, to let them all know of your desire that they should take seriously the Simple Solution to unity that is given in the Unity Treatise. You are also asked to contact all your Urantia friends, family and associates and ask each of them to join you, with us, and read the Unity Treatise, then discuss it among yourselves. Ask them to do as we do and join us in this effort. And lastly you are asked to join us in adding your name to the next issuance of *Unity Treatise Petition* that was already been sent to UF, TUBF and UAI. (See below and see the Urantia Treatise Unity Petition attachment).

FAILURE OF THE UNITY EFFORT BY THE ORGANIZATIONS:

It is now clear that there is only but one workable solution to foster unity among the two fraternal Urantia reader organizations, and that is the Simple Solution contained in the Unity Treatise. It is also clear that there is only one way that Urantia Foundation will ever have unconditional and unlimited spiritual and financial support and all necessary resources from all our unseen friends and all the committed readers of The Urantia Book, so that they (UF) can professionally translate and publish millions of The Urantia Book and achieve their Principal Objects and Concordant Objects, is by adopting the Simple Solution contained and described by the author(s) of the Unity Treatise. The TUBF organization's unity failure together with the UA-USA/UAI is now officially evidenced by the recent unanimous vote of The Urantia Book Fellowship to reject unity with Urantia Association of the United States of America / Urantia Association International. TUBF at the same meeting also officially chose to further their disunity by continuing publishing their own "version" of The Urantia Book.

And sadly, Urantia Foundation, after receiving the Unity Treatise, made no effort to aid them in bringing Unity to the Urantia revelation movement by citing their recent policy of non-interference in the reader groups (Please note that this policy is not found in the Declaration of Trust [DOT]). This non-interference policy is actually counter to their DOT Principal Objects and Concordant Objects. To understand this further, please see the Principal Objects written in the Declaration of Trust (See copy below for your further understanding).

This failure of TUBF and UAUS/UAI to achieve <u>True</u> Unity by their own devices demonstrates that any attempt by them to achieve True Unity that is not in association with Michael's Plan for Urantia's future, is dead in the water, and all future attempts not in accordance with the judgment of the Conciliating Commission Sojourning on Urantia, will be of no avail. They will remain forever unsanctioned, in default and continue in disunity, unless they swallow their spiritual pride now.

MICHAEL'S "PLANS" TO ACTION (ITS'S IN THE BOOK):

21:5.9 (241.3) "After his elevation to settled sovereignty in a local universe a Paradise Michael is in full control of all other Sons of God functioning in his domain (including us), and he may freely rule in accordance with his concept of the needs of his realms.

A Master Son may at will vary the order of the spiritual adjudication and evolutionary adjustment of the inhabited planets. And such Sons do make and carry out the plans of their own choosing in all matters of special planetary needs, in particular regarding the worlds of their creature sojourn and still more concerning the realm of terminal bestowal, the planet of incarnation in the likeness of mortal flesh." (Italics and Underlines are mine).

We have been gifted with the fifth epochal planetary revelation, *The Urantia Book*, in accordance with the *Plans of Michael*, but his goals and purposes for his revelation have been and still are stifled by the leaders of the three Urantia organizations and have been subdued for now more than sixty years.

The corrections to these problems and our disunity are addressed by the Unity Treatise in detail. But, they are of no avail to Urantia progress if our leaders continue to act as if they and they alone know more of what is best for Michael's revelation then does Michael and his Revelatory Commission.

This letter then is a call to you, The Soldiers of the Circles, who were selected to receive *The Urantia Book* and now the Unity Treatise, for you so to act now by adding your voice and name to those of us who have already contacted <u>our</u> three Urantia organizations to tell them of our wishes that they should join in Unity, obey the instructions in the Publication Mandate, follow the Declaration of Trust's Principal and Concordant Objects, Purposes and Goals.

The Unity Treatise was sent to you only after it was summarily rejected by the actions or inaction of <u>all three</u> Urantia organizations, so that you, as a Soldier of the Circles, may act together in joining with the forces from above and with hundreds of other brave Urantian souls on Urantia who are committed to make our voices heard as true *Urantians in Unity*. We do this in effort to set right the revelation's Objects, Purposes and Goals using the methodology written in the governing documents authorized given by the Revelators.

You are Michael's and his Revelator's only hope for our Urantia organizations to set right their goals—to achieve their Principal Objects and Concordant Objects, and do so by the mandates and methodology that originally came with *The Urantia Book*. If you are still not convinced to act and you have not read the original governing documents of the three organizations, please go on line, find them and read them now to understand this more fully.

WE NEED YOU TO ACT AND ACT NOW:

We need you to act and now by personally and collectively contacting all three organizations (and do so many times). Let them all know of your displeasure with their lack of TRUE UNITY, their total disregard of the Revelatory Commission's *Publication Mandate* (See TUBF website), their neglectful indifference of the methodology noted in their governing documents, their lack of carrying out their Principal Objects and Concordant Objects, and the confusion caused by their having more than one publisher of the book.

We now ask you Soldier to act personally to contact all three organizations and at the same time to join with us and add your name with those of us who have already sent a Unity Treatise Petition to these same three organizations. We need you to stand your ground with us, much as did the Mighty Messengers in their days in the flesh. You are also asked to tell your Urantia organization's leaders that their sole purpose is not just to print books, have them translated, have Urantia conferences, or publish study group lists and manuals, but that they are obligated to carry out, as Michael ordained through his Revelatory Commission, their Principal and Concordant Objects, by or "...through fostering a religion, a philosophy and a cosmology which are commensurate with Man's intellectual and cultural development." And achieving all this by fostering thousands upon thousands of Study Groups; by officially training and certifying *Urantia Teachers* and disseminators of The Urantia Book; by training certified Urantia Leaders to organize and maintain these thousands and thousands of Urantia Study Groups, societies, associations, etc.; by and through establishing worldwide Halls of Religion, superb Universities of Philosophy, and grand Institutions of Cosmology that will attract all advancing mankind. This they must proclaim theirs to do!

These Urantia organizations have never taken Michael's Revelatory plans seriously. We need your help to act now to also tell these failing organizations that for them to regain the full support of our unseen planetary government, <u>ALL</u> Urantians (affiliated or not), as well as the Revelatory Commission, the Planetary Government and Michael; they need to demonstrate to all and everyone their Unity as <u>one</u> publisher of *The Urantia Book*, and one Urantia Brotherhood.

REQUIRED OBJECTS OF URANTIA FOUNDATION — DECLARATION OF TRUST OF URANTIA FOUNDATION:

ARTICLE II: OBJECTS:

"2.1. PRINCIPAL OBJECT: The object for which this Foundation is created is the promotion, improvement, and expansion among the peoples of the world of the comprehension and understanding of Cosmology and the relation of the planet on which we live to the Universe, of the genesis and destiny of Man and his relation to God, and of the true teachings of Jesus Christ; and for the inculcation* and encouragement of the realization and appreciation of the Fatherhood of God and the Brotherhood of Man—in order to increase and enhance the comfort, happiness, and well-being of Man, as an individual and as a member of society, through the fostering** of a religion, a philosophy, and a cosmology which are commensurate with Man's intellectual and cultural development."

2.2. CONCORDANT OBJECTS: The concordant objects for which the Foundation is created are to perpetually preserve inviolate the text of *The Urantia Book* and <u>to</u> <u>disseminate*** the principles, teachings, and doctrines of The Urantia Book</u>. (Underlines are mine.)

*Inculcation is the instilling of knowledge or values in someone, usually by repetition. To inculcate is to instill or impress an idea on someone, so inculcation is the process

of instilling or impressing ideas. A lot of teaching is a form of **inculcation**: teachers repeat information to students, hoping it will sink in.

- **Fostering is to encourage or promote the development of (something, typically something regarded as good).
- ***<u>Disseminate</u>, **disseminated**, **disseminating** is to scatter or spread widely, as though sowing seed; promulgate extensively; broadcast; disperse: to **disseminate** information about a truth.

Origin of **disseminate:** Expand.

PLEASE ACT NOW MY FRIEND!

We need you to act now to take a firm stance in your support of true and real Urantia Unity; adherence to the Revelatory Commission's Publication Mandate and for the three Urantia organizations to finally begin to achieve their revelatory Principal and Concordant Objects, Goals and Purposes as is required of them in their respective Declaration of Trust. Constitution and Charter.

This is your call to action to all Soldiers of the Circles who support *The Urantia Book*'s revelatory long term planetary objectives and who wish to make sure that it will be available in full force and in place at that future time as per Michael's plan with:

- 1. Thousands upon thousands of *fostered* study groups,
- 2. Millions of committed, loyal and dedicated readers,
- 3. Thousands of halls of religion <u>fostered</u> worldwide and based on the knowledge of God and the *Life and Teachings of Jesus*,
- 4. Numerous *fostered* Universities of advanced Philosophy and
- 5. Hundreds of *fostered* institutions of Cosmology.

With all of these spread throughout Urantia; and with all of these based on the supernal teachings of *The Urantia Book* and the *Life and Teachings of Jesus* our Master Son; and with all to be made available for that not too far-distant time "...after the current ideological struggles are over when billions upon billions of Urantia's mankind will hunger and thirst for the revelatory knowledge of God our Universal Father and His universal creation." (see the Publication Mandate).

DISUNITY AND DISHARMONY:

The Urantia Revelation is indeed in disunity. We have three differing organizations whose leaders continue even now to go in their own directions, and they ignore and even compete with one another. As a result, TUBF and IUA are not growing as Urantia Brotherhood once did. Offshoot organizations are splintering and gathering a dismal few readers here and there who refuse to participate in the disunity that they feel is propagated by a politically motivated Urantia leadership. The Internal Guides of these independent souls are telling them to refrain from these disputing organizations that were originally selected and destined to lead Urantia forward toward light and life, but who now dispute among themselves and only wish to satisfy their own needs and whims as they apply Michael's revelation.

OUR URANTIA ORGANIZATIONS IN SCHISM ARE MISSING THEIR MOMENT:

The Unity Treatise author(s), upon reporting on the Conciliating Commission's (CC) findings and Simple Solution, have taken the time and prepared the Unity Treatise <u>for our Urantia leaders</u>. However, these leaders are missing their moment to advance and progress. Our Trustees and leaders have all <u>outright rejected the gift</u>. Now it requires you and I to join together with the Unity Treaty author(s) (who by the way are not the CC itself) in convincing these Urantia leaders of our wish for them to join in real and true Unity by following the Publication Mandate, carrying out the Objects, Purposes and Goals of their own governing documents.

And!, Urantia Foundation should consider that there is a vast difference between a policy of noninterfering with the affairs of the fraternal organizations and an action of carrying out their spiritual responsibility of being in harmony with the reader groups. And UF should demonstrate this by making every effort, legally and otherwise, to reinstate TUBF's name as Urantia Brotherhood's and revitalized as the Urantia Brotherhood Corporation in the State of Illinois as once it was with all corporate rights to use the registered name Urantia marks as they once did.

SADLY TUBF OFFICIALLY DECLINED UNITY AND CONTINUES PUBLISHING THEIR OWN BOOK:

The Fellowship within this past month officially moved against unity and decided to continue going their own separate way. As a result UAI told their constituent leaders to be cooperative with TUBF, but go about their own business, while Urantia Foundation by its deafening silence and Non-Interference Policy appear to not care at all to comply with the Revelator's Publication Mandates that came with text of *The Urantia Book*, or to comply with their own Principal and Concordant Objects. They voiced nothing. It was recently announced on the internet that The Urantia Book Fellowship (TUBF), in their last meeting, have by near unanimous vote, outright rejected unity among the organizations and agreed not to discuss it again. As I said before, TUBF also voted to continue publishing the Uversa Press' version of *The Urantia Book*.

But be not fooled: UAUS/UAI never actually advocated true and real unity with the TUBF, except in so far as promoting <u>cooperative</u> joint programs between TUBF and UAI's national organization, the Urantia Association of the United States of America (UAUS). The orchestrated these attempts at this pseudo unity only among their leaders, for neither reader services organization ever <u>officially</u> informed the leaders of their local associations and local societies officials of their attempts at unity. Nor did they share with them the very real "Simple Solution" to achieve true and real Unity that was given to them by the Conciliating Commission now sojourning on Urantia and elaborated in the Unity Treatise. They never informed their membership of the existence of the Unity Treatise. They hid the Unity Treatise away from all of them. They decided on their own the fate of the Urantia Revelation for their constituents and without their knowledge. And again: UF said and did nothing!

ITS'S NOW YOUR TURN AND RESPONSIBILITY TO ACT!

All three organizations continue to show no interest in the Unity Treatise, so now it is your turn to act to convince them otherwise!

But still it is sad to note that to this date, Urantia Foundation, The Urantia Book Fellowship, and Urantia Association International have not only rejected the Simple Solution to Unity in the Unity Treatise, but they never even acknowledged receipt of it, never shared it, never studied it and thus never adopted it. They also never privately or publicly acknowledged that for mankind's good, there needs to be:

- 1. REAL Unity,
- 2. ONE Urantia publisher (UF) of *The Urantia Book*, and
- 3. ONE and only one Urantia Brotherhood (UB)
- 4. A need for them to follow the Publication Mandate, their own Principal and Concordant Objects and their own governing documents as originally written.
- 5. And acknowledge that as all these were originally established by the Revelatory Commission.

Think of it: Urantia organizations have also never once acknowledged the existence of nor their obligations to carry out the Revelatory Commission's Publication Mandates. Neither have they ever accepted and followed their own methodology, that is stated therein or to achieve their own DOT Trust Objects, Constitutional Goals and Chartered Purposes. They are personally bent on leading the Fifth Epochal Revelation as they personally see fit, not as Michael would have it. They refuse guidance from those who gave them the book that they cherish. And, it is now finally decided and evident by their recent vote and their responses to it, or lack of them, to continue to go their own way—away from our Master Son's Plan. Sad Indeed! But, I believe that with your voices added together with ours and sent to the three organizations we will be heard. If not on earth, at least it will be heard on high.

We pray our leaders ultimately will listen to our plea!

It is also truly sad to note that upon receiving the Unity Treatise, their leaders not only did as much as they possibly could to hide it from their supporters, members and constituents, but they made every effort to discredit it and convince those readers like you, who received and responded to the Unity Treatise, to reject it outright. And they have been very successful with some. I lost my New England friends as a result. But, I forgive them for they really do not understand the significance of their actions, for I believe they are acting against the wishes of our Master Son to rehabilitate Urantia, his planet of nativity, through the dissemination and fostering of his Urantia revelation by the methods his Melchizedek Revelatory Director ordained in the Publication Mandate, and by the Principal and Concordant Objects in the Declaration of Trust and respective Constitutions as clearly pointed out by the Unity Treatise.

GATHERING THE TROOPS:

I write this letter because I was admonished by my anonymous friend, when I originally was first given the Unity Treatise to put it into Word/PDF format and send it to the three organizations, that if it was clearly unacknowledged and rejected by the organizations, that I was to send you the Unity Treatise, so that our combined voices, and the voices of all we convince to do likewise, would join together into the ranks of the "...Soldiers

of the Circles..." as one *unified* spiritual force, supported from above, so that we together may act to convince the leaders of the three (3) Organizations that our wish is for them to usher in a new generation of Real and True Unity; with one publisher, and to operate their organizations as mandated by the Revelators in *The Urantia Book*'s Publication Mandate and as their Declaration of Trust, Constitution and Charter dictates.

I STILL SUPPORT UF, TUBF and UAI:

By doing this we will then demonstrate, with the Unity Treatise's Author(s), our continued support of and remaining faith in our Urantia Leadership's ability to still join together in real and true Unity as one united *Urantia Brotherhood*, with one *Publisher*, and that we still respect the author(s)' and Conciliating Commission's faith in our Urantia leaders in them. And we will continue to do so until such time as these Urantia leaders irreversibly reject the Conciliating Commission's judgment and Simple Solution to Unity, and they find themselves all alone and to their own devising.

To help Michael, it requires our joined voices to be shouted out so as to be heard and heard now!

By giving our leaders the Unity Treatise, its author(s) have demonstrated that they have faith enough in these each of them to eventually follow their hearts and spiritual leadings to enact the plan of Michael to get ready Urantia for those not too far distant days ahead when all mankind hungers, thirsts and searches for God. The author(s) provided them with the Unity Treatise most likely at the request of Michael, and did this knowing full well of these leaders' past history of self-direction and their steadfast continued disbelief in the actual revelatory origins of the Fifth Epochal Revelations, and that our unseen revelational originators were real then when the book became manifest and remain real and very active today. Consequently, with their past outlook, we can understand the reluctance of our Urantia organization's leaders to accept the Unity Treatise as representative of the recent CC decisions found in it concerning the governance of the Urantia revelation.

The *Unity Treatise* has come to us at a time of gross disunity among the adherents of the Urantia movement with their continuing refusal to follow their own Objects, Purposes and Goals as were and still are mandated by the Revelators. The Unity Treatise comes as perfumed balm for an open festering wound, and gives us a detailed presentation on how the organization's mandate to actual and true unity can be healed and accomplished as one Urantia Brotherhood with one Publisher, most easily, and as originally and officially planned by the Revelatory Commission. Ever remember that this Revelatory Commission was acting THEN and is STILL is acting now under the supervision of Michael's appointed Melchezedek Revelatory Director and under the authority of <u>all</u> those authors of the Urantia Book papers who hail from the *Uversa Revelatory Commission*, for they too were given mandates, and they followed them to the letter (as we should be doing also). But, our leaders have virtually ignored our mandates.

TIME IS OF ESSENCE:

Our Urantia leaders still have time to conform, and it does not take a rocket scientist or a nuclear physicist to figure out that if they do not do as they should—<u>others will</u>. Will you help them to see this now with your voice added to ours?

UNITY TREATISE PREPARED TO CARRY OUT THE WISHES OF MICHAEL:

To be clear and I state once again that it appears that this Unity Treatise apparently was prepared and given to our leaders for them to carry out the wishes of Michael for Urantia. And, Michael's wish is for his revelation, *The Urantia Book*, to be in place with thousands upon thousands of study groups, thousands of trained teachers of the revelation, with official systematic training certification programs for thousands of needed organizational and study group leaders, preparing these and then having them all in place with millions of dedicated and committed readers in established and vast numbers of worldwide halls of religion, advanced universities of Philosophy and highly respected Institutions of cosmology with all located around the world and all based on the supernal *Life and Teachings of Jesus* and *The Urantia Book*; and all this to be fully established and carried out now for that near future time when many billions of Godhungry and thirsting souls on our world will be searching for our Universal Father.

This is the plan, object, purpose and goal of Michael for his revelation to and for Urantia. He has the power to see this through! Will you join us as one of his Soldier of the Circles and petition the organizations to this end? Will you now join us in having your name placed on our *Unity Treatise Petition*? And will you induct others into our ranks to do likewise?

INTRODUCTION TO THE UNITY TREATISE PETITION: By Halbert Katzen

The "Unity Treatise" has developed as a handy reference to both the cover letters and the PDF and a Unity Treatise Petition was started as a result.

The person who wrote the Unity Treatise Petition, Halbert Katzen, is known to many in the UB community as the creator of <u>UBtheNEWS.com</u>, which documents how new discoveries and scientific advances increasingly support the version of planetary history found in The Urantia Book. More recently, he has been building the <u>UBannotated.com</u> website as a study aid for both hardcopy and online versions of The Urantia Book.

Halbert has taken great interest in the Unity Treatise for its practical merits on a "truth from any source" basis. I asked him if he would like to include a few remarks of his own in this email. He said he would and wishes to communicate the following: "The intention of writing reports for the UBtheNEWS project was not only to bolster credibility for The Urantia Book's assertion of superhuman authorship (in a way that everyone else can use and appreciate as they please), but also to bolster credibility for myself as set about to systematically do outreach to university professors and researchers, whose work had a direct relationship to some aspect of a UBtheNEWS report.

"Cold calling professors and researchers face-to-face about The Urantia Book are not "any easy sell" by any stretch of the imagination. To my knowledge no one else has ever even tried such an approach on a broad-based systematic level. (I am aware of some individuals doing this on a more localized level that worked with being a member of the given community.) Certainly, my experiences would have gone more smoothly if I had been able to also carry certification as an Urantia Book Teacher and/or Leader, in harmony with the perspective provided by the Unity Treatise.

"From the beginning of the UBtheNEWS project I thought that it would not be wise to try to do the work in any official capacity with either of or both of the social organization. My concern was that political influences might unduly impact the presentation and development of the work. Sadly, these concerns (which I could not envision with specificity at the beginning) were abundantly validated as the project developed and in some notably specific ways.

"I did not anticipate how the most impressive reports would have so much to do with race issues, leading to the publication of the Eugenics, Race, and The Urantia Book paper. With the discomfort people have around this aspect of the revelation, the incongruity that this whole approach to outreach has in relationship to the current interfaith outreach efforts, the willingness some "reader-believers" have to reject this aspect of the revelation, and the credential related facets associated with this type of the outreach, small wonder that the UBtheNEWS project has not found much institutional support over the years for the essence of the project, has suffered the criticism of "not being spiritual enough" in the outreach approach, and being otherwise untimely and overly intellectual.

"Since reading the Unity Treatise, for the first time I have come to appreciate that, if the main organizations were truly focused on fostering institutions of cosmology, as their charters direct and the Unity Treatise explains they were intended to do, then work related to the UBtheNEWS project would naturally find a home in the organizational structure of the community. I now see that one of the main problems is that the institutions, in trying to be everything for everybody, create a cultural competition for resources and community focus. This fails to respect the spectrum interests and dispositions found in the community (humanity, generally).

"The (Revelator's) brilliant original plan involved fostering institutions that align with the three fundamental energy systems of life—religion (spirit), philosophy (mind), and cosmology (matter).

"Please consider the importance of adding your name to the Unity Treatise Petition. In my 35+ years of being a reader-believer, these are the best ideas I have ever seen for improving the community. It really is that simple. On a truth from any source basis, I cannot see why reader-believers would reject the value of the perspective and directives found in the Unity Treatise. But if you do, please feel free to get in touch. If you are sincere about all of this, I am sure I would love to talk to you about it no matter what your current perspective.
